**ADVERTISEMENT FOR FILLING UP OF THE POSTS OF CHAIRPERSON AND
MEMBERS OF STATE FOOD COMMISSION, TAMIL NADU**

Applications are invited **through offline mode** for appointment to the posts of a Chairperson and five members in the Tamil Nadu State Food Commission, set up by Government of Tamil Nadu under the provisions of the Tamil Nadu Food Security Rules, 2017. The Chairperson / Members of the State Food Commission are to perform such duties and functions and exercise such powers as prescribed under the Tamil Nadu Food Security Rules, 2017. The Head Quarters of the Commission shall be at Chennai.

2. Eligibility Criteria:

- (i) The Chairperson / Members shall be appointed from amongst persons:-
 - (a) Who have been members of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State, having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or in any allied field; or
 - (b) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health, food policy and public administration; or
 - (c) who have a proven record of work relating to the improvement of the food and nutrition rights of the poor.

3. Age limit and tenure:

The Chairperson / Members of the State Food Commission shall hold office for a term not exceeding five years from the date on which he/she enters upon the office, and shall be eligible for re-appointment, provided that no persons shall hold office as Chairperson/Members after he/she has attained the age of 65 years. The Chairperson/Members shall not concomitantly hold any other office.

1. The applicants are advised to go through the provisions of the Tamil Nadu Food Security Rules, 2017 and satisfy themselves about their eligibility and other conditions for being appointed as Chairperson/Members.

The candidates who fulfill the eligibility criteria given above may send their applications in the prescribed Proforma hosted on Department's website-www.tnpds.gov.in, together with the self-attested copies of supporting documents addressed to "**The Additional Chief Secretary to Government, Department of Co-operation, Food and Consumer Protection, Secretariat, Chennai 600 009**" by post or in person, on or before **30.01.2023 by 6.00 P.M.**

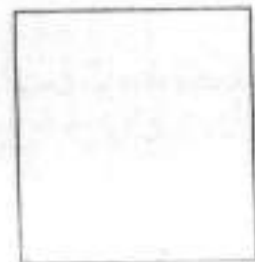
The candidates working in Government/PSUs/Autonomous Bodies etc. must send their application through proper channel along with self-attested copies of the supporting documents.

- 1) Self Attested copies of the relevant documents in support of proof of age, academic qualifications and experience to be attached.
- 2) Applications sent through FAX or received after last date will not be entertained.

Terms and Conditions of Service of Chairperson and other Members of Commission:

- (1) The salaries and allowances payable to and other conditions of service of :-
- (a) the Chairperson, shall not be below the rank of Secretary to Government .
 - (b) the other members shall be the same as that of the lowest scale (fixed) for the "Joint Secretary to the Government" and be paid Dearness Allowance as admissible to the post of the Joint Secretary.

Provided that the salaries, allowances and other conditions of the service of a member who is not a recipient of any form of a pension, other than a disability pension, in respect of any previous service under the Government of India or under any State Government shall be paid with an honorarium of an amount not exceeding Rs.50,000/- (Rupees Fifty Thousand Only) per mensem. Such member shall also be eligible for payment of Rs.500/- (Rupees Five Hundred only) per sitting per diem.

- (2) The Chairperson and other members shall not be entitled to any pension for their service rendered in the Commission.
- (3) The Chairperson or any member of the Commission may, by notice in writing under his hand addressed to the State Government, resign from the office of the Chairperson or the member, as the case may be, at any time.

Provided that the members shall forward a copy of his resignation to the Chairperson and the resignation shall take effect only from the date of acceptance of the resignation by the State Government.

- (4) A casual vacancy of Chairperson or Member shall be filled up as soon may be, the appointment of another member by this State Government from the panel of names recommended by the Selection Committee referred to in Rule 16. The person so appointed shall hold office for the remaining period of the tenure of the member in whose place he is appointed.
